1. Extension application to extend the currency period of development approval (DA2018/10) for a further 1 year period to 4 November 2022.

  - Schedule 10, part 17 division 3, Table 2, Item 1 capital dredging berth pocket, approach and dock, reclamation, sheet piled wharf, sheet and tubular piled dock, guide pile, navigation aid and stormwater outfall.
- b) Assessable development on Strategic Port Land and Strategic Port Land tidal area *Planning Regulation 2017* reference:
  - Schedule 10, part 13 Ports, division 5, subdivision 2, Table 1 Operational works for disposal of dredged material.
