Contractors	Person(s) or companies working on a service or task for or on behalf of any part of GPC, but whose employment is not directly associated with GPC. You are an entity paid by GPC under a commercial arrangement or a subcontractor to an entity paid by GPC	There is no specific role that manages all contracts for GPC. Each contract will have a designated Contract Owner, Delegate and Supervisor that depends on the nature of the work and level of risk to GPC. To ascertain who the contract supervisor is, a contractor should inquire with their own company.
Crew Transport and Bus Operators	A Company approved to transport Crew, Pilots, and other personnel to and from the wharf but who are not engaged by GPC. It includes but is not limited to taxi's, Gladstone seafarers and approved transport operators. Does not include Truck Drivers transporting cargo to or from a GPC Facility. Emergency Services and Military	Emergency Services personnel who are attending GPC facilities as a Planned event or Australian or Foreign Defence Personnel. Essential Service & Utilities	A Utility company or Rail provider that requires access to GPC Facilities to service their own assets and are not directly engaged by GPC. Includes but not limited to Aurizon, Pacific National, Telstra, Ergon, GAWB and Gladstone Regional Council. Marine Service Providers	A company that requires access to a GPC Facility to conduct works on- board a vessel on behalf of the vessel owner or shipping agent, but who are not engaged by GPC. Other	Anyone engaged by a GPC Port User to conduct works on GPC sites. Includes but is not limited to: - Contractors and sub-contractors to other Port Users, Defence Personnel, Regulatory Bodies and GPC tenants - Truck Drivers engaged by Port Users - Approved Trade Unions and ITF	The GPC Representative for this personnel type will depend on who the Port User is that requests the work. For example a truck driver engaged by a GPC Tenant at Auckland Point will have a different GPC Representative to a worker engaged by an agent to service a Vessel at RG Tanna. To ascertain who the GPC representative is, inquiries must be made through the Port User who engaged the worker.
Product Owners	A company that engages GPC to handle cargo or products on their behalf. For example Coal Company. Includes but is not limited to ABF, DAWR, AMSA, MSQ, DNRME. If in doubt contact GPC property Department.
