TERMS & DEFINITIONS

CHARGES

All Wharfage and Harbour Dues will be directed to the owner of the cargo or the receiver of the cargo (as the case may be). Tonnage Rates payments will be directed to the Master of the vessel or his/her Agent.

HARBOUR DUES

Are a cargo-based charge levied on users of the Port of Bundaberg shipping channel. Certain commodities may however attract specific negotiated charges. Unit charge for Harbour Dues is Per Tonne.

WHARFAGE RATES

Is a cargo-based charge levied on users of the Port of Bundaberg wharves. Unit charge for Wharfage is Per Tonne.

TONNAGE RATES

Is a shipping-based charge levied on the ship owner using port infrastructure. Unit charge for Tonnage rates is per day at berth.

PAYMENT TERMS

The due date for payment is 1 month after the end of the invoice month.

OVERDUE ACCOUNTS

The due date for payment is one month after the end of the invoice month. Interest at a rate of 10% per annum will be calculated daily on any unpaid amounts will be charged from the due date of the invoice for payments not paid in full.

LISTED RATES

All the rates listed are indicative rates only and are subject to review by the Corporation. If circumstances arise where a Product, Item or Berth is not listed please contact the Port Manager to obtain rates.

MANIFESTS

All documentation is required by GPC no later than 1 business day of a vessel sailing. Manifests should clearly state both weight and volume if applicable on all non-containerised cargos and charges will be levied on whichever gives the higher revenue. Cargo Origin and Destination is required.

STANDARD CONTAINER SIZE

A Standard Container as recognized by GPC is 19.875 foot (TEU) (6.0581mtr x 2.438 x 2.59). Rates for containers greater than 20 foot will be adjusted on a pro rata basis. Minimum chargeable unit is a 20 foot container. Standard 20' container is 38.253 c.m. For Charging - Flat Racks are considered Containers and Skids are General Cargo.

ROUNDING AND GST

Rounding of charges which incorporate GST are in accordance with Tax Office rulings.
